

Corrigendum

It is notified to all concerned that some minor modifications have been done in the eligibility criteria and last date of application submission regarding **"Offering student internship to selected postgraduate students of the Faculty of Veterinary Science"** under the ALSBT-Hub 'Student's internship' head as notified vide letter No. 99/DRV/341/2022-23/Internship/5730-35 dated 23.02.24 to pursue their project works with the following terms and conditions:

1. A postgraduate student of the Faculty of Veterinary Science, AAU who is **in their 3<sup>rd</sup> semester or successfully completed 3<sup>rd</sup> semester of his/her M.V.Sc. course** in any discipline will be eligible to apply for the student internship. However, the fellowship will be offered only for the 4<sup>th</sup> semester, irrespective of their current status. Selection will be made strictly on merit basis, as determined by OGPA/CGPA secured at the UG level. However, preference will be given to those who have selected a topic of research (as documented by approved synopsis) on any topic related to the thrust areas of research identified for the Advanced Level State Biotech Hub (Assam).
2. The amount of studentship will be Rs. 8,000.00 (Rupees Eight thousand) only per month for a periods of six months. No extension will be allowed in any case.
3. During the period of studentship, the student will not be entitled to draw the University's Merit Scholarship or any other scholarship/stipend.
4. In-service candidates are not eligible to apply for the studentship.
5. The awarded students will have to acknowledge the financial support received from the DBT-funded Advanced Level State Biotech Hub in his/her thesis and a copy of the thesis has to be submitted to the ALSBThub.

Interested PG students may submit their applications through concerned HoD in the prescribed format enclosed directly to Dr. Dipak Deka, Project Coordinator, DBT-funded Advanced Level State Biotech Hub (Assam), Dept. of Animal Biotechnology, College of Veterinary Science, AAU, Khanapara, Guwahati-22 **on or before 20<sup>th</sup> March, 2024.**
