

## **Logo Design Contest**

### **Indian Society for Veterinary Immunology and Biotechnology (ISVIB)**

The Indian Society for Veterinary Immunology and Biotechnology (ISVIB) is holding a contest among the students at selected Veterinary Colleges of the country to adopt a logo for the Society. In the first phase, the three top entries in each selected college will be awarded appreciation certificates and the final winning entry selected out of the winning entries of the first phase will be given a cash prize of Rs. 5,000/- during the XXX Annual Convention of the Society to be held at IVRI, Mukteswar campus from 9-11 October 2025.

Interested students (both UG & PG) of the Faculty of Veterinary Science, Assam Agricultural University may submit their logo designs online through <https://forms.gle/dLfGyNaA16cD9xKk6>. Entries submitted through any other medium/mode would not be considered for evaluation. **The last date for submission is 14<sup>th</sup> August 2025.**

#### **Terms & Conditions for Log Design Contest**

1. The participant must ensure that his/her personal profile including the contact number and email is accurate, as the organizers will use the information for further communication. Entries with incomplete profiles may be rejected.
2. The Contest is open to only the present students on roll, either in CVSc, Khanapara or LCVSc, North Lakhimpur.
3. The winning logo would be the intellectual property of the Society as soon as the results are declared, and the winners cannot exercise any right over them thereafter. The winners shall be deemed to have surrendered copyrights of the winning logo to the contest organizer as soon as the results are declared. The prize-winning logo may be used by the contest organizers in any manner they deem fit.
4. The contest organizer reserves the right to modify (or fine-tune) the prizewinning logo, *i.e.*, the unfettered right to modify the prize-winning logo design and add or delete any information or design feature in any form to it.
5. The contest organizer also reserves the right not to use the prize-winning logo at all, and/ or to use an alternative logo.
6. The logo must not contain any provocative, objectionable or inappropriate content.
7. Only one entry per participant would be considered.
8. The logo must be original and should not violate any provision of the Indian Copyright Act, 1957.
9. The organizer does not bear any responsibility for copyright violations or infringements of intellectual property carried out by the participants.
10. The design of the logo must not infringe on the Intellectual Property Rights of any third party. All entries will be governed by the provisions of Logos and Names (Prevention of Improper Use) Act, 1950 and any violation of the said Act will result in disqualification.
11. The participant must be the same person who has designed the logo, and no plagiarism of any kind would be allowed.
12. All the entries received will be assessed by the Selection Committee for final evaluation. The

decision of the Selection Committee would be final and binding on all the contestants and no clarifications would be issued to any participant or any decision of the Selection Committee.

### **Technical Parameters**

1. Participants should upload the logo in JPEG or PNG format only.
2. The logo should preferably be a letter-based one.
3. The size of the final design may vary from 4 cm x 4 cm to 12 x 12 cm. (Note: The dimensions above indicate only the minimum and maximum 'frame' sizes of usage.)
4. The logo should be in high resolution with a minimum of 300 DPI.
5. Once selected and the winner is acknowledged, all rights with respect to the logo shall be transferred to ISVIB thereafter, the copyrights of logo will be the sole property of ISVIB.
6. Participants should not imprint or watermark the logo design.
7. In the event of selection, the contest organizers may ask the winner to resubmit the entry in different size(s)/format(s), etc. to suit their requirements.
