- 01. The quotation fee of Rs. 300.00 (Rupees Three Hundred) only in the form of a Demand Draft to be drawn in favour of DIRECTOR OF RESEARCH (VETERINARY) payable at SBI, Khanapara Branch (Branch Code: 09945) is not refundable. If the quotation documents are downloaded from the website, the quotation fee in the form of a DD must be submitted along with the quotation, without which the quotation will be rejected.
- 02. The bidder shall enclose the Earnest Money Deposit (EMD) of Rs. 25,000.00 (Rupees Twenty Five Thousand) only in the form of a DD drawn in favour of the DIRECTOR OF RESEARCH (VETERINARY), payable at SBI, Khanapara Branch. The bids that are not accompanied by the aforesaid bid security will not be accepted. The details of bid security must be provided in the cover letter. The bid security of the unsuccessful bidders will be released after issuing supply order to the successful bidder. The bid security of the successful bidder will be released after completion of one year from the date of the price approval after receipt of application from the bidder.

- 04. The bid submitted shall remain valid for 90 (ninety) days, and the quoted price once approved shall remain valid for at least one year. Bid not conforming to this provision shall be treated as nonresponsive. It will be the discretion of the AAU authority to extend the validity of the approved rate(s) for further period(s), subject to agreement of the supplier to supply the items at the approved rate(s) during such extended period.
- 05. Quotation must also be submitted in a soft copy in CD or any other media (to support in Microsoft Word only) in the following format failing which the bid will be treated as non-responsive, at the discretions of the purchaser. Any discrepancies in the soft copy will be the responsibility of the bidder. **Format**

- 06. Bidders must supply the items at their own cost at the sites mentioned above.
- 07. The rate shall be quoted for all duties, taxes and other levies payable by the bidder shall be included in the item rate. GST should be quoted separately (GST No. must be furnished)
- 08. There should not be any overwriting. Corrections, if any, should be made with dated initial of the bidder.
- 09. Rates should be quoted clearly both in words and figures separately for each item, without which the quotation shall be rejected outright.
- 10. Detailed specification of the feed and the name of the manufacturer along with the user list including the contact number of the users, should be furnished.
- 11. Test report(s) from a reputed laboratory of the feeds to be supplied must be submitted along with the quotation to ascertain the feed quality as per requirements. Otherwise, the quotation will be treated as invalid and rejected outright.
- 12. Attested copies of the Dealership Certificate from the original producer/manufacturer must be enclosed with the quotation.
- 13. The price quoted shall be fixed and not subject to adjustment/variation during the performance of the contract.
- 14. Up-to-date Sale Tax clearance certificate and Income Tax return of the last three years duly attested, must be submitted along with the quotation. PAN No. must be furnished
- 15. Delivery has to be completed within 10 (Ten) days from the date of issuing the supply order.
- 16. The bidder must mention their Bank details along with the quotation.
- 17. Wherever the laws and regulations require, deduction of taxes at source of payment, the purchaser shall affect such deduction from the payment due to the supplier, the remittance of amounts so deducted and insurance certificate for such deduction shall be made by the purchaser as per the laws and regulation in force.
