India payable at Jorhat, will have to accompany all quotations to be submitted.

Quotations submitted without appropriate amount of earnest money are likely to be rejected. **Accumulated earnest money for instruments should be shown in your forwarding letter.**

Earnest money deposit will not bear any interest, and have to be in the form of demand draft only.

5 **Rates:** Rates quoted must be on FOR Instructional Poultry Farm, College of Veterinary Science, Assam Agricultural University, Khanapara, Guwahati- 781022 on DOOR DELIVERY Basis.

Break-ups of cost:

- a. Basic Price
- b. (+) Freight & transportation charge if any.
- c. Bidders shall indicate their rates in clear/visible figures as well as in words and shall not **alter/overwrite/ erase/ cut** in the quotation. In case of a **mismatch, the rates written in words will prevail.**

6. Delivery of items at Instructional Poultry Farm (IPF), CVSc, Khanapara, Guwahati, will have to be maximum within 45(Forty-five) days from the date of issue of the Purchase Order.

7. **Mode of Payment:** After successful delivery of items at IPF, CVSc, AAU, Khanapara Guwahati-22, payment will be generally made through A/c payee cheque. In case payment is to be made by DD, the Draft commission will be deducted from the bill amount.

8. Late and delayed tender will not be considered. In case any unscheduled holiday occurs on prescribed closing the next working day shall be the prescribed date of closing.

9. No enquiry shall be made by the bidder(s) during the course of evaluation of the tender till final decision is conveyed to the successful bidder(s).
